They are appointed by the monarch for life and governed by the statutes of [Koninklijke Notariële Beroepsorganisatie](#). Their functions include, but are not limited to, probating estates, preparing wills, articles of incorporation, agreements between individuals, and transferring title in real property transactions. Notaries are required to establish the veracity of information presented to them and their functions have the force of law.
